Criteria for writing manuscript for publication

in the Srinakharinwirot Science Journal

- 1. To publish an article in the Srinakharinwirot Science Journal, the article must be peer reviewed by at least 2 expert reviewers.
 - The article from Srinakharinwirot University staff will be assessed by the external reviewers.
 - The article from external submitter will be assessed by internal and/or external reviewers.
- 2. The assessment result will be informed to the manuscript author within three months. Therefore, the Srinakharinwirot Science Journal will not put into consideration any of the articles that need publication result within 1 month.
- 3. The editorial team will not review any manuscripts that are not conformed to the requirements/criteria for writing manuscript for publication in the Srinakharinwirot Science Journal.

The field of research that will be accepted for publication

Srinakharinwirot Science Journal will accept quality research and academic articles in the field of Science, Mathematics and Science Education that have never been published elsewhere in any journals and are not currently under consideration for publication elsewhere.

The type of literature that publish in the journal

- 1. Research Article that has never been published in any journals or books before.
- Academic Article such as written works from documents and books which include favorable opinion or comment in the field of Science, Mathematics and Science Education that have never been published in any journal or book before.

The Preparation of Manuscript

- 1. The Manuscript can be in Thai or English language but each article has to include both Thai or English abstract.
- 2. The Manuscript paper size is A4 paper print on one side with 2.5 cm margin on all sides
- 3. The Font and font size both Thai and English use Browallia New
 - 3.1 Title: 18 pt. thick
 - 3.2 Author; 16 pt. normal
 - 3.3 Main topic: 16 pt. thick
 - 3.4 Sub topic: 14 pt. thick
 - 3.5 Abstract and body: 14 pt. normal
 - 3.6 Footnotes include work place and email: 12 pt. normal
- 4. The first page of Manuscript includes Title, Author, Abstract and Footnotes all in Thai language while second page includes Title, Author, Abstract and Footnotes in English.
- 5. To submit the Manuscript, the authors have to submit online.
- 6. The amount of pages of Manuscript should not exceed 15 pages.
- 7. The images should be in black and white only.
